CLUB DESCRIPTION

Londonderry Fish & Game Club is a sporting club located on 83 acres in Londonderry, NH. 25, 50 and 100 Yard Ranges, a Trap Range and Archery areas are available for use. Members are issued individual keys to the club, which does not have an on-duty range master. LFGC charges no range and facility use fees and members use the club FREE OF CHARGE.

Membership Terms and Club Meetings

Memberships start in January and run through December. Members joining after September 1st will entitle their membership to continue through the next annual membership cycle.

Membership in the NRA **is required** for membership as the club is an NRA-endorsed club and insurances are obtained through the National Rifle Association.

Membership renewals are \$120 annually, continued membership in the National Rifle Association, and Good standing as a member for the prior term. The full fee may be offset in the amount of \$30 with at least one participation in an annually scheduled club work party.

Monthly Membership meetings are held **every first Tuesday of every month, 7:30 PM at the Club**, throughout the calendar year, unless otherwise posted or noticed. Timely information and details may be found at:

Club Facility Use Rules

- 1.No member shall conduct any organized event on the club property without first obtaining the express written consent from the Officers and Board of Directors for Londonderry Fish and Game Club.
- 2.No member shall build, install or construct any permanent structure upon club property without first obtaining the express written consent from the Officers and Board of Directors for Londonderry Fish and Game Club.
- 3.All locked gates shall remain locked upon entry to the club property and shall not be left open, unless physically attended at all times while open.
- 4.Junior Members may **not** use the club facilities without the presence of a parent, guardian or other legally authorized person. Junior members who have attained the age of 16 or 17, **and** have completed an IHEA-Sanctioned Hunter Education Course, may be authorized to use the facilities without a parent or guardian present. Said

Junior member, however, ***may not*** have a guest or guests accompany him or her, unless a parent or guardian is present.

Range Use Rules

1. The ranges are for use only by club members and their accompanied guests. Junior members must be under the supervision of an adult, ages 18 or older.
2. **Firearms muzzles shall be pointed in a safe direction at all times.**
3. All Firearms shall be unloaded with the actions open when people are forward of the firing line.
4. Targets shall be placed as close as practical to the backstop burms. Used targets shall be taken down and carried out when shooting is finished. Glass and alcoholic containers are forbidden on Club property, excepting meetings and work parties.
5. Shooters shall wear eye appropriate eye and ear protection.
6. The discharging of any firearms is to take place exercising safety at all times and, only on a designated range and only from the firing line of that range.
7. No Alcoholic beverages are permitted on the ranges. No persons under the influence of alcohol or drugs is permitted on any range.
8. The range officer, any elected club officer, or any member of the board of directors may, at any time, ask any person to leave the range; or may, at any time close the range.
9. Fully automatic firing firearms are permitted ONLY on the 25 Yard Utility Range and shall be of a sub gun caliber utilizing common handgun cartridges only. Full Auto Rifles shall only be utilized at Sanctioned Club events.
10. Semi-automatic firearms may not be fired in a manner, that simulates full automatic fire in an unsafe manner.
11. Members must wear their club membership card while on club premises.
12. **Shooting hours are from 8:00 am to one half hour after official sunset.**
13. All injuries and accidents shall be reported immediately to a club officer or member of the board.

Terms and Conditions for Membership

Any person who presents him or herself for membership in the Londonderry Fish and Game Club, Inc., and signs the membership application, certifies with their signature that they meet the following terms and conditions:

1. That the member renewing or new member applicant is not under indictment or information in any court, for a felony, or any other crime in which incarceration for more than a year could result.
2. That the member renewing or new member applicant has not been convicted of a felony or any other crime for which incarceration of more than a year resulted.
3. That the member renewing or new member applicant is not an unlawful user of and/or addicted to illegal drugs.
4. That the member renewing or new member applicant is not a fugitive from justice.
5. That the member renewing or new member applicant has not been adjudicated as mentally defective.
6. That the member renewing or new member applicant is not the subject of (defendant) a court order restraining activities of harassing, stalking, or threatening.
7. That the member renewing or new member applicant has not been convicted of misdemeanor domestic violence.

8. That the member renewing or new member applicant has not renounced his or her United States citizenship and is not an alien illegally present in the United States.
9. That the member renewing or new member applicant is not a member of any organization, group, club or association whose purpose, goals and objectives contravene the bylaws, principles, goals or purposes of the Londonderry Fish and Game Club, The National Rifle Association or general principles of sporting firearms, Archery, hunting and fishing.
10. That the member renewing or new member applicant practices safe and ethical use of firearms and archery equipment.

Waiver and Acknowledgement

By accepting membership in the Londonderry Fish and Game Club and making use of the facilities thereof, the member renewing or new member applicant acknowledges that he or she will use the club for recreational purposes only and LFGC shall not be liable for personal injury or property damage in the absence of intentionally caused injury or damage.

The member renewing or new member applicant hereby acknowledges that the use, handling and operation of firearms, Archery equipment, arrows and live ammunition presents inherent risks of serious bodily injury and or death and therefore, agrees to abide by all safety rules promulgated by the LFGC membership and/or its Board and Officers. The member renewing or new member applicant further agrees to indemnify and hold harmless, the Londonderry Fish and Game Club, its Officers and Board of Directors from any and all liability arising from same. Additionally, The member renewing or new member applicant agrees to indemnify and hold harmless, the Londonderry Fish and Game Club, its Officers and Board of Directors from any and all liability arising from the actions of individual members or member's guest.
